3. Note to the authorised representative

Scope of power of attorney

This power of attorney entitles the authorised representative to perform all transactions with ProCredit Bank AG that are directly related to account management.

The authorised representative is specifically permitted to

- dispose of account balances (e.g. via transfer) and in this context set up term deposits,
- receive and acknowledge account settlements, account statements and other notifications.

The authorised representative must submit all instructions in writing on paper.

The power of attorney does not entitle the authorised representative to

- modify client contracts,
- change the reference account,
- make use of e-Banking,
- grant sub-power of attorney rights and
- issue or change exemption orders.

Closing of accounts

The authorised representative may not close an account until after the death of the account holder.

Duration of power of attorney

The power of attorney may be revoked by the account holder at any time vis-à-vis the bank or the authorised representative. If the account holder should decide to revoke the power of attorney vis-à-vis the authorised representative, he or she shall inform the bank in writing immediately. The power of attorney does not expire upon the death of the account holder. It remains in force for the heirs of the account holder.

Should any of several joint-heirs revoke the power of attorney, the authorised representative may then only represent those joint-heirs that have not revoked the power of attorney. In this case, the authorised representative may only perform transactions together with the heir(s) who revoked the power of attorney. The Bank may demand proof that the person revoking the power of attorney is a legitimate heir.

Please carefully complete this power of attorney form and sign it.

Please note, we cannot set up a power of attorney until the legally required verification of the identity of the authorised representative has been completed.

Note to the authorised representative

The bank is required by law to retain the name and address of any authorised representative. This information will therefore be stored. Please note: it is only possible for the authorised representative to issue instructions to perform transactions in writing.

The next steps

- Please complete this form carefully and make sure that it includes all of the necessary signatures and send us the form by post.
- If the authorised representative is already our client or if he has already carried out the legally required identity verification, then he does not need to act further.
- Otherwise, the authorised representative listed on the form must verify his identity either at the branch of ProCredit Bank with their identification card or passport or through the Postident procedure of the German Post Office. If the authorised representative has specified a foreign nationality or a foreign registered address he will have to present the passport (not an identification card) to the post office employee who carries out the Postident procedure. If the authorised representative has a second nationality, please provide a copy of the second passport (not the identification card) with this form.
- At the post office, an employee will ask to see your identity card (if you are a German national) or passport in order to verify your identity. The data collected in the process is transmitted to us electronically. This service is free of charge.
- At the branch of ProCredit Bank, an employee will ask to see your identity card or passport in order to verify your identity. The employee will enter your data into a form and will send both directly to us.
- We will send you the confirmation of the power of attorney to your e-Banking mailbox.
